### TERMS & CONDITIONS

1. Both Tenders (Technical+ Financial) should be submitted in separate envelopes marked as Technical and Financial
2. Call deposit in favor of Principal Vocational Training Institute Fort Abbas @ 2% of amount quoted for total items should be attached with the (Technical Bid) tender documents.
3. Tender received after the due date & time will not be brought under consideration.
4. Attested copies of Income Tax and Sales Tax number should be furnished by the firm along with the tenders.
5. The successful firms will be responsible to deliver the items to the concern institute along with complete documents/ accessories.
6. The competent authority may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The competent authority shall upon request communicate to any bidder the ground for its rejection of all bids or proposals, but shall not be required to justify those grounds.
7. Successful bidder shall be bound to provide performance Security @ 10% of the estimated price, which will be returned after the expiry of warranty period i.e. One year.
8. As per Govt. rules, Income Tax, GST and any other Govt. Tax (if applicable) will be responsibility of the bidder.
9. Delivery period of all items shall be 20 days from the issuance of purchase order.
