- Tender received after the due date & time will not be brought under consideration.
- Attested copies of Income Tax and Sales Tax number should be furnished by the firm along with the tenders.
- The successful firms will be responsible to deliver the items to the concern institute along with complete documents/ accessories.
- Any Or the total bids can only be rejected on the basis of evaluation criteria. Though, (i) The Procuring Agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. (ii) The Procuring Agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds."
