- ➤ Interested eligible bidders (NTN + GST Registered) may get the tendered item's specification immediately after publication of this tender from the PPRA website "https://eproc.punjab.gov.pk", PVTC website "www.pvtc.gop.pk" & E-Pak Acquisition and Disposal System (EPADS).
- > Single stage, Single envelope basis bidding procedure shall be applied.
- Proposals/bids are to be submitted only electronically through EPADS till 10:00 AM on 10-Nov-2025 and shall be opened in the presence of authorized representatives of firms/ contractors (As per PPRA Rule) at office of Principal VTI Depalpur (Basir Pur Road, Near Police Khidmat Center, Depalpur) at 11:00 AM on 10-Nov-2025.
- ➤ The Bid Security / Earnest Money (2%) **Rs.39,600/-** in the form of "CDR i.e. Bank Draft, Pay Order etc." in favor of "Principal Vocational Training Institute Depalpur" is required to be submitted before closing date.
- Without Bid Security / Earnest Money the offer shall be rejected being non-responsive.
- > Current minimum Wages rates fixed by the Govt. of Punjab for the category "Security Guards" must be followed as per Punjab Gazette.
- ➤ (Circular PPRA Govt. of Punjab S&GAD 1211): After the laps of given time between the declaration of technical evaluation report and opening of financial no grievance petition would be entertained concerning the technical qualification of successful bidder.

Note: All assessments and procuring procedure i.e. receiving, opening and awarding etc. shall be governed by the Punjab Procurement Rules-2014.

TERMS & CONDITIONS

1. General:

- 1.1 Any offer not received as per terms & conditions of the tender enquiry is liable to be ignored. No offer shall be considered if:
 - ♦ Received without earnest money Rs.39,600/- (2% of estimated tender value given in tender add)
- It is received after the time and date fixed for its receipt
- Not signed by authorized person on each page of tender document
- ♦ The offer is ambiguous
- ♦ The offer is received by fax or e-mail
- The Firm never blacklisted on any ground by PPRA Punjab and Procuring agency.
- Offer received with shorter validity than required
- The offer is not conforming to requirements indicated in the tender documents
- Rate quoted in decimal (it must be in round figure).
- Rate quoted found other than the tender documents
- ♦ Any conditional offer
- 1.2 Tax registered, having at least one-year relevant experience in security services and valid license holder firms / companies are eligible to participate in the tender.
- 1.3 Offered rate will remain valid for a period of 180 days. The contract will be enforced for a period of one year.
- 1.4 The cover envelop should indicate particulars of tender, and date of opening. The envelopes must be properly sealed.
- 1.5 The earnest money / bank guarantee shall be forfeited if:
- a. The acceptance of tender is not received within ten days of issuance of order
- b. The offer is withdrawn, amended or revised.
- c. The Security Agency fails to execute the contract strictly in accordance with terms and conditions.
- 1.6 The bidder should indicate their National Income Tax No. / Sales Tax No. and circle of Income Tax Department.
- 1.7 Competent authority may reject all bids or proposals at any time prior to the acceptance of a bid or proposal as per PPRA rules. Competent authority shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.
- 1.8 Wages rates fixed by the Govt. of Punjab for the category "Security Guards" must be followed under the PPRA circular no. L&M (PPRA) 10-01/2011 dated 03rd Dec 2018 and any amendments / revisions made by Govt. of Punjab in this context.
- 1.9 Circular PPRA Govt. of Punjab S&GAD 1121: After the laps of given time between the declaration of technical evaluation report and opening of financial no grievance petition would be entertained.

2. Cancellation / Penalty:

- 2.1 If the acceptance of the tender issued during the validity period of the tender is not acceptable by the bidder, the earnest money shall be forfeited.
- 2.2 In case the offer is withdrawn, amended or revised during the validity period of the tender, the earnest money shall be forfeited.

- 2.3 In case, the bidder fails to execute the contract in accordance with the terms & conditions laid down in the contract, performance bond / bank guarantee will be forfeited and security services can be hired from another company (in order of merit described in evaluation report or re-tendering otherwise) at risk and cost of the bidder.
- 2.4 In case of poor performance, President DBOM of VTIs, Okara may cancel the contract or impose appropriate penalty. The penalty may be up to double the approved rate of per month of total service charges.

3. Payment to the Security Agency:

- 3.1 Payment will be made through crossed cheque to the Security Agency against the sales tax invoice after satisfactory performance within 30 days.
- 3.2 Payment against partial arrangements of Security Guards will not be made.

4. Earnest Money:

- 4.1 Earnest money **(2%) Rs.39, 600/-** will have to be deposited through courier or personally before closing date. It should be in the form of Pay Order / Bank Draft / Call Deposit in favor of Principal Vocational Training Institute Depalpur.
- 4.2 Earnest money of unsuccessful bidders shall be refunded on the finalization of the contract / tender whereas the earnest money of successful bidder shall be refunded on the submission of performance bond.

5. Performance Bond:

1-Year performance bond in the shape of CDR/ DD or bank guarantee from scheduled bank to the satisfaction of Administration of VTI Depalpur equivalent to 10% of the total contract amount will have to be furnished within 10 days after the award of contract. Bank guarantee will be returned after successful completion of the contract period. In case repeated orders, the bank guarantee will be returned after the completion of repeated orders.

6. Inspection of Security Services

The security services will be inspected by the VTI through authorized personnel/committee who will coordinate with the security agency in lieu of performance of security guards as per tender requirements / terms & conditions of contract.

7. Deduction of Taxes:

Any taxes (Income Tax, Sales Tax etc.) will be deducted while making payment as per Government instructions / notifications.

8. Payment of Income Tax & other taxes:

Contract will be executed with tax registered firms. Income tax and all other such taxes will be liability of the Security Agency.

9. Termination of Contract:

President DBOM of VTIs, District Okara may terminate contract for convenience assigning reasons to the contractor in writing with compensation of services delivered to the purchaser if applicable.

10. Dispute:

In case of any dispute before or after the execution of contract, matter will be resolved as per PPRA Rules' Clause 67 & 68. President DBOM, VTIs District Okara or his nominee shall act as sole arbitrator. The decisions taken and/or award made by the sole arbitrator shall be final and binding on the Parties

12. Information about firm:

The Security Agency will provide information along with tender about the following:

- a. Company profile and professional experience
- b. List of satisfied customers / companies along with their addresses and contact numbers / contact persons
- c. Copies of Tax Registration Certificates
- d. Authorization from Home Department

13. Security Services' Terms & Conditions:

- a. The Security Agency will provide 03 Security Guards with licensed weapon and equipment (metal detector, whistle & torch on company cost) as per tender specification to VTI Depalpur, 03 Security Guards in shifts. 03 Security Guard will perform the duties, tasks and Works pertaining to the establishment and maintenance of an effective and reliable security service at the premises of **Vocational Training Institute Depalpur** Basir Pur Road, Near Police Khidmat Center, Depalpur. Number of Security Guards can be increased / decreased by the VTI Depalpur for which written request will be made to the Security Agency by the VTI.
- b. The Security Agency will ensure that its personnel perform their security duties efficiently, vigilantly, honestly, faithfully and in the most substantial manner required in their profession. The persons employed by the Security Agency shall be treated as the Security Agency's employees.
- c. The Security Agency will provide medically fit & duly verified Security Guards to the Concerned VTI.
- d. Fixation of timings / place of duty / working hours for duty of Security Guards provided by the Security Agency shall be made by the VTI Depalpur.
- e. The contract will be enforced for a period of one year, which may be extended up to three years on satisfactory performance of security agency.
- f. The Security Agency will provide one weapon to each Security Guard along with appropriate ammunition without any extra charges. Ammunition used by the Security Guards while performing duties will not be charged from the VTI Depalpur.
- g. In case, any of the Security Guard provided by the Security Agency is found guilty of misconduct, he will be returned to the Security Agency forthwith for taking necessary action. However, the Security Agency in the meantime shall immediately arrange replacement within 06 hours.
- h. The Security Agency will be responsible for any loss due to negligence of Security Guards provided by him for security related matters. The value of damaged / stolen items will be determined by joint inquiry as per recommendations by both the parties. The inquiry committee will comprise one representative each from the VTI and security agency. Inquiry report / facts / findings will be submitted to the President DBOM of VTIs, District Okara for his final decision.
- i. Each Guard must be fully equipped with Weapon with minimum 24 bullets/cartridges each time.
- j. Metal Detector, Whistle, Torch, Uniform, Shoes and bullets/cartridges will be provided by the security company.
- k. Clearance of security guards from Police station/special branch will be provided before joining duties.
- I. Security firm will be bond to provide monthly salary to security guards as per approved minimum wage rates by Punjab Government and submit detail to procuring agency.
